The minimum skills and knowledge expected for the whole workforce from the Workforce Strategy

#### 1. Safeguarding & Welfare

- · Identifying harmful behaviour, neglect or abuse
- Aware of legal obligations for disclosure
- Understanding risk factors & effects
- · Facilitating discussion
- Listening to concerns and planning solutions

### 2. Communication and Engagement

- Develop trust & respect
- Display transparency in choices & decision making
- Consulting, informing & negotiating
- · Active listening & understanding
- Use clear language

#### 3. Child Development

- Recognise physical, intellectual, linguistic, social & emotional growth
- Early identification of developmental difficulties
- Understand the role of attachment in child development and relationships
- Understanding of mental health

## 4. Integrated Working & Information Sharing

- Understand data protection legislation
- Early intervention
- Understand the importance of informed consent
- Recognising the need for and when to make a referral
- Work effectively with multi-agency teams
